To the extent that I, individually, or my heirs, successors, assigns, or personal representatives bring a claim of any kind whatsoever against Champaign Community Unit School District #4, Champaign Central High School and/or Champaign Central High School Interact Club 5K and/or their employees, agents, and representatives, I agree that this Waiver, Release and Indemnification Agreement is to be construed under the laws of the State of Illinois.
